The clause denotes the permissibility of trusts in establishing and managing educational institutions under the purview of the CBSE guidelines.

Our institution, Alpha International School, is governed and managed by a registered trust as per CBSE Bye-Laws, adhering to all legal formalities and ethical standards. We firmly believe in the significance of providing quality education and contributing to the academic growth of students in line with the CBSE standards.

Hence our school does not need a society to run a school as our school is being run by a Trust.

iv. to extend the funds of the trust in such manner as they shall consider most beneficial for the purpose of the trust,
v. to acquire, build upon, pull down, rebuild and to alter, repair, improve, sell or dispose off or otherwise deal with any land, building or premises or property for the use of the trust:
vi. to take any property on lease or hire.

h) The trustees shall be entitied to be indemnified by the trust properties against the consequences of all lawful acts done by the trustees in the course of their discharging their duties as trustees of the trust and all costs, charges and expenses thereof:

1) The trust hereby constituted fails for any reasons, the net assets of the trust shall be made over to any public charitable trust having objects similar to this trust and enjoying exemption u/s 11 and 80 G of the Income tax Act,1961, as may be resolved by the trustees;
2) Not more than $5 \%$ of the income of the trust shall be applied for any religious purposes or given to any religious institution;
k) Save as otherwise provided in these presents, the provisions contained in the above said original trust deed, rectification and amendment deeds are applicable to the trust,

(c)The bank account(s) shall be opened in the name of the trust and shall be operated only by the Chairman for the time being until contrary is decided;

## 11. ACCOUNTS AND AUDIT

a) The Chairman shall keep proper accounts of the trust. income and expenditure, financial statements and balance sheet for every year as on the last date $31^{\text {w }}$ March shall be prepared and signed by the Chairman and secretary,
b) The accounts shall be got audited by a Chartered Accountant appointed by the board every year fixing his remuneration.

## 12. GENERAL

a) The trust is irrevocable and any properties of the trust will never be revert back to the founder or to the trustees;
b) The incorne of the trust will be solely towards the objects and no portions of it shall be used for payments to the frustees by way of profit,
c) The benefit of the trust are open to all irrespective of caste, creed, religion, sex, etc.;
d) Any amendment to the trust deed will be carried out only with the approval of the Director of Income tax (Exemption). Chennai-600 034 or any authority as may be prescribed:
e) No activities of the trust shall be carfied out anywhere outside India.

1) The trust shall not carry on any activity with the object of earning a profit;
g) The seal of the trust shall bear the inscription 'ALPHA EDUCATIONAL TRUST and shall remain in the custody and control of the Chairman,

## (iv) POWERS OF THE SECRETARY

a) Tres Secretary for the time being shall assist the Chairman to negotiate, execute and to do all other necessary documents to carry out all or any of the powers of the trust excluding the borrowings and shall do so for and on behalf of the trust only and any acts and deeds done in his personal capacity shall not bind the trust :
b) The Secretary shall assist the Chairman in managing the affairs of the trust and the other organisations corning under the trust by convening the meetings, maintaining the records and registers.
c) The Secretary shall also assist the Chairman to represent the trust before any Government, semi Government, banks, creditors and others:
d) The Secretary shall also assist the Chairman in the matters of receipts and payments, maintaining the accounts, arranging for audits and other regular activities;

## 9. CUSTODY OF DOCUMENTS

Title deeds, Investments and securities, Books of accounts and other Records and Registers belonging to the trust shall be in the permanent custody of the Chairman for the time being ,

## 10. BANK ACCOUNT

(a) All income subscriptions and pecuniary donations for the general purpose of the trust and the income or investments and all other moneys from time to time forming part of the general revenue of the trust shall on the same being received be paid into an account with any nationalised or scheduled bank which the board may determine from time to time;
(b) The trustees shall not mix up the trust funds with his own at any point of time;

xi. to settle out of the court, compromise or compound all suits, actions and other proceedings and all differences or demands and to refer all or any of the such differences or demands to arbitration and to execute a releases and to settle and approve all accounts without being answerable for any loss occasioned thereby:
xii. To appoint and dismiss managers, secretaries clerks and other staff,
